Responsibilities:

- All staff will be required to work August 9, 2024 from 8:30 A.M. to 12:30 P.M. This closing session will be utilized for completion of records and reports, packaging materials and supplies and closing rooms. Students will also be in attendance on August 9, 2024.
- Professional staff will be assigned depending upon student enrollment program requirements.
- Teaching Assistants will be assigned from 8:30 A.M. to 12:30 P.M. daily.
- Teacher Assistant responsibilities will include: attending to personal needs of students dressing, toileting, feeding, etc., lifting, handling and positioning, techniques of physically handicapped students; supervision at lunchtime; working with the students in academic and other areas of instruction under the supervision of a teacher or professional.

Criteria for Selection of District-Wide Personnel:

- The minimum requirement of all teaching staff is appropriate New York State Certification.
- Teachers presently servicing Special Education students at the age/grade level of the summer school enrollees will be given preference if all other factors are equal.
- ▶ Certified Teacher Assistants will be given priority in the selection process.
- ▶ Teacher Assistants presently working with Special Education students will be given preference.
- Satisfactory summer service in <u>continuous</u> summer appointments will be the primary procedure for staff selection per contract. <u>Previous summer school attendance will also be considered for continued employment as students require consistent instruction</u>.
